WHEREAS, said coupons would be presently due and payable; and

WHEREAS, the Bank of America N.T. & S.A., Sacramento, desires pay-in-lieu of issuance of new coupons; and

WHEREAS, Section 53460 et seq., of the Government Code of the State of California applies in connection with lost or destroyed bonds; and

WHEREAS, an indemnity letter has been received from the Bank of America N.T. & S.A., Sacramento, to indemnify the City for possible loss due to making such payment; and

WHEREAS, this Council is satisfied by competent proof that Coupon #12 from City of San Diego Penasquitos Sewer District 1970 Sewer Bond, Series A, A1868 and A1869, have been lost, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer is hereby authorized to make payment in the sum of \$362.50 in lieu of these lost coupons.

BE IT FURTHER RESOLVED, that the City Treasurer place in the City Treasurer's files the letter of indemnity from Bank of America N.T. & S.A., Sacramento.
