WHEREAS, the Bank of America N.T. & S.A., San Diego, desires pay-in-lieu of issuance of new coupons; and

WHEREAS, Section 53460 et seq., of the Government Code of the State of California applies in connection with lost or destroyed bonds; and

WHEREAS, an indemnity letter has been received from the Bank of America N.T. & S.A., San Diego, to indemnify the City for possible loss due to making such payment; and

WHEREAS, this Council is satisfied by competent proof that Coupon #32 from City of San Diego Sewer Revenue Bonds, Bond Nos. 35119/23, 33616/35, and 36267/91, have been lost, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer is hereby authorized to make payment in the sum of \$1,000 in lieu of these lost coupons.

BE IT FURTHER RESOLVED, that the City Treasurer place in the City Treasurer's files the letter of indemnity from Bank of America N.T. & S.A., San Diego.
