WHEREAS, under an agreement between The City of San-Diego and the Regents of the University of California, of October 21, 1974, the Bicentennial Year Project, known as Fronteras 1976, received grants and donations totaling \$77,717.63 which were given to the City as financial agent for Fronteras 1976; and

WHEREAS, in the Fronteras 1976 Executive Committee meeting of November 30, 1976, the Committee recommended "to the parties to the Fronteras joint agreement that any residue of funds remaining be used for any Fronteras-type organization that may be established."

WHEREAS, expenditures for the 26 months of operation of Fronteras 1976 totaled \$73,524.97, leaving a balance of \$4,192.66 in the Fronteras 1976 account; and

WHEREAS, UCSD Chancellor William D. McElroy concurred in the transfer of the remaining funds of Fronteras 1976 to Fronteras de las Californias; NOW, THEREFORE,

BE IT RESOLVED, that the City Manager is hereby authorized and empowered to transfer funds in the amount of \$4,192.66 which is the amount remaining from sums donated to the City for Fronteras 1976 from the Fronteras 1976 Account (Fund 2761) to the successor organization of Fronteras 1976, which successor organization is — Fronteras de las Californias.
