That the bid of \$527,000 by Penhall Company, a corporation, for the DEMOLITION AND REMOVAL OF THE ABANDONED HARBOR DRIVE SEWAGE TREATMENT PLANT, Base Bid minus Deductive Alternate No. 1, in the City of San Diego, California, is hereby accepted and the City Manager is hereby authorized to execute a contract therefor in the form on file in the office of the City Clerk as Document No. 761096.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to expend the sum of \$554,700 out of appropriate federally-funded accounts solely and exclusively for the purpose of providing funds for said project and related costs.
