1. That the base bid of \$229,992.75 by Griffith Company, a corporation, for the IMPROVEMENT OF MARKET STREET FROM 47TH STREET TO EUCLID AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 761097.
2. That the expenditures of \$292,490.00 out of appropriate federally funded accounts solely for said purpose; and \$13,950.00 from Gas Tax Reserve Fund 220; and \$29,100.00 from Capital Outlay Fund 245 are hereby authorized solely and exclusively for providing funds for said project and related costs.
