

RESOLUTION NO. 219598

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access by Map No. 1505 affecting Lots 22 and 23 of Boulevard Gardens, filed in the office of the San Diego County Recorder; and

WHEREAS, the Engineering and Development Department has requested that the City revest these abutter's rights of access in the property to ARTHUR E. WILSON and ALYCE J. WILSON, husband and wife as joint tenants, as to an undivided one-half interest, and PETER ROZOK and LORENA B. ROZOK, husband and wife as joint tenants, as to an undivided one-half interest, the owners of said property, to provide access to their property; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights; and

WHEREAS, a fee of seventy dollars (\$70) has been received as the negotiated sale price of the property right; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf



ROZOK, the owners of said Lots 22 and 23 of Boulevard Gardens, effecting the revestment of those abutter's rights of access heretofore relinquished to the City, more particularly described in said form of quitclaim deed.
