WHEREAS, Council authorized an agreement with The County of San Diego for the operation of an Automated Regional Justice Information System (ARJIS); and

WHEREAS, the purpose of ARJIS is to provide a system in which electronic data processing processes may be used to achieve rapid and efficient handling of data, records, information and transactions and other tasks associated with the administration of justice; and

WHEREAS, a program entitled Justice Records Information

System (JURIS) has been devised to provide an integral element

within ARJIS; and

WHEREAS, said JURIS contemplates and encompasses the use of cathode ray terminals (CRT) for rapid receipt of data necessary to perform the various tasks associated with the administrative processes in the prosecutorial function; and

WHEREAS, the program has now progressed to that point at which it is necessary and desirable to install a CRT terminal in the City Attorney's office to provide a common circuitry with the County and other participating agencies in ARJIS; and

WHEREAS, this terminal will serve as a demonstration model _______
to provide the City with empirical data from which further
terminals may be warranted; and

WHEREAS, the rental cost associated with the use of said terminal is approximately \$300 per month; and

WHEREAS, it is anticipated that the terminal will be installed no earlier than January 1, 1978; and

WHEREAS, it is necessary to provide funds for payment of said monthly rental charges and minimal installation costs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$2,000 from the Unallocated Reserve (53.31) to the City Attorney's Department (09.40), Object Account 3414, to be used solely and exclusively for costs associated with rental of a CRT terminal for the JURIS program.
