BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$7,500 from the Transient Occupancy Tax Unappropriated Reserve Fund Contingency Reserve Program (52.99) to the Super Q Bowl (52.93) for reimbursement to the San Diego Stadium operations fund for related expenditures.
