BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the Bid of \$1,389,370.00 by W. F. MAXWELL, INC., a corporation, for CONSTRUCTION OF HARBOR DRIVE OVERPASS AT THE ATCHISON, TOPEKA AND SANTA FE RAILWAY CO. TRACKS, in the City of San Diego, California is hereby accepted and the City Manager is hereby authorized to execute a contract therefor in the form on file in the office of the City Clerk as Document No. 761127.
2. That the expenditure of \$73,390.00 is hereby authorized out of the Capital Outlay Fund 245 and that the expenditure of \$138,190.00 is hereby authorized out of the Gas Tax Fund 220 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
3. BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to expend the sum of \$1,466,367.00 out of appropriate federally-funded accounts and \$100,000.00 from Senate Bill 283 solely and exclusively for the purpose of providing funds for said project and related costs.
