


RESOLUTION No. 219628

2. BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to expend the sum of \$30,200.00 out of appropriate federally-funded accounts solely and exclusively for the purpose of providing funds for said project and related costs.
