

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease agreement with PACIFIC SOUTHWEST REALTY COMPANY, as Lessor, leasing 6,159 square feet of space in the ninth floor of the Security Pacific Plaza Building at an initial monthly rental of \$4,749.20, for a term of five years, under the terms and conditions set forth in said form of lease agreement on file in the office of the City Clerk as Document No. 761831.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$50,000 from Fund 100 for rental, moving costs, and alterations for office space in the Security Pacific Plaza Building is hereby approved.
