
RESOLUTION No. 219664

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$68,000.00 by DBX INC., DBA PERRY ELECTRIC, a corporation, for CONSTRUCTION OF STREET LIGHTING SYSTEMS ON IMPERIAL AVENUE BETWEEN 24TH STREET AND 32ND STREET, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760363.
2. That the expenditure of \$76,121.00 is hereby authorized out of the Second Year Block Grant Fund 290 and that the expenditure of \$13,279.00 is hereby authorized out of the Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
