RESOLUTION NO. 219669

APPROVING MAP OF CORONADO VIEW

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by LEROY C. BODAS, Registered Civil Engineer, entitled "CORONADO VIEW Being a subdivision of a portion of Lot 18 of the Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to the partition map thereof made in an action under Superior Court Case No. 348, entitled "Juan M. Luco, et al, vs. the Commercial Bank of San Diego, a corporation, et al", and on file in the office of the County Clerk of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets and a portion of a street, to wit: Chaumont Drive, Chaumont Place, Ballina Drive, Tooley Street, Tooley Circle and a portion of 60th Street for public purposes, and said streets and a portion of a street are hereby declared to be public streets and a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to 60th Street, adjacent and contiguous to Lots 1 and 2, 66 through 68, inclusive, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and a portion of a public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, CORONADO VIEW ASSOCIATES, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 761667, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of CORONADO VIEW.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
