WHEREAS, during his nine consecutive years as the Chargers' premier pass receiver, Lance Alworth set 15 of 16 all time club pass receiving records including: most receptions lifetime, 493; most receptions during a season, 73; most receptions during a game, 13; most yards lifetime, 9585; most yards during a season, 1602; most yards during a single game, 292; most touchdowns lifetime, 81; best yards per reception average for a season, 23.2; among others; and

WHEREAS, during his 11 years as a player in the National Football League, Lance Alworth has earned a spot in the record books among the best all time receivers in seven pass receiving categories including: second in consecutive games in which he caught at least one pass, 96 and second in total yards gained, 10266; among others; and

WHEREAS, Lance Alworth is the first member of the San Diego Chargers Hall of Fame and

WHEREAS, Lance Alworth has made the San Diego community his home; and

WHEREAS, The City of San Diego is proud to recognize and commend the outstanding achievements of its community residents;
NOW, THEREFORE,


