

1. That the bid of ~~\$21,628.00~~ by HACKETT CEILING & LIGHTING, INC., a corporation, for CONSTRUCTION OF MEMORIAL PARK AND RECREATION CENTER GYMNASIUM IMPROVEMENTS, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760750.
2.
