BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a grant agreement with the URBAN MASS TRANSPORTATION ADMINISTRATION (UMTA) in the amount of \$2,168,368 for the purchase of nineteen (19) standard size buses, ten (10) supervisory sedans, ADP equipment and the implementation of Project FARE, under the terms and conditions set forth in the form of grant agreement on file in the office of the City Clerk as Document No. 761907.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$26,289 from Public Transportation Reserve Fund 2571 to Transit System Purchase 19 buses Fund 2579, to cover the 1 1/4% sales tax not eligible for Federal participation.
