

RESOLUTION No. 219712 (R. 78-891)

Adopted on NOV 16 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized to submit to the Department of Housing and Urban Development an amended 1978 Community Development Block Grant Application which is on file in the office of the City Clerk as Document No. 761879, and which includes the following amendments:

1. Alters the entitlement amount by increasing it from \$10,200,000 to \$10,772,000 or \$572,000. Said additional funds are to be allocated to the Low Income Housing (\$417,708) and Contingency (\$154,292) program categories.
2. Lists certain current CDBG funded Public Service Projects as proposed 1978 activities. These projects are Legal Services, San Ysidro Schools, Business Outreach and Barrio Station.
3. Makes other minor adjustments to statistical tables within the Housing Assistance Plan. Such adjustments will not have an appreciable effect on the total information provided.
