WHEREAS, the Planning Commission of The City of San Diego has held concurrent public hearings to consider the Uptown Medical Complex Plan, and amendment of the Uptown Community Plan in order to retain consistency between said Uptown Medical Complex Plan, Uptown Community Plan, and the General Plan; and

WHEREAS, on May 12, 1977, the Planning Commission adopted and recommended for adoption to the City Council an amendment to the General Plan Map; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider said amendment to the General Plan Map; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That this Council hereby adopts that amended General Plan Map entitled, "Progress Guide and General Plan for the City of San Diego," incorporating the Uptown Medical Complex Plan, a copy of which amended General Plan map is on file in the office of the City Clerk as Document No. 762209.
