<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Albert L. Shepard	Utilities	\$1000	Mr. Shepard is a Senior Engineering Aide in the Water Quality Division. He developed a corrosion control test lead station for use on City pipelines. The use of this test station saves the City \$24,377 annually in the time it takes to check for corrosion.
Stephen C. Holmes.	General Services	\$1000	Mr. Holmes is an Equipment Mechanic in the Equipment Division. He suggested a method of unloading disabled trash packers utilizing an alternate packer. The use of this method saves the City \$10,480 annually.
William T. Evans	Building Inspection	\$ 255	Mr. Evans suggested that Form IN-13 be revised to include the plan file number. By including this number on the form, hundreds of hours are saved annually in looking for plans in need of correction. Annual savings are \$2545.
Jack Dickens Joe Burgos Dick Creighton Fred DeMattos Ralph Ekiss Tom Gordon John Kelloge Jack Kersell Don Oate Bobby Sharpe Walt Westwood Howard Wygle	General Services	\$ 180	This crew from the Equipment Division devised an alternate means of unloading disabled trash packers through the use of a standby pump and auxilliary engine. This method has saved the City \$1800 in one year's time.
