<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Gloria J. Butler	Financial Management	\$ 10	Ms. Butler is a Program Typewriter Operator. She suggested that the final budget document be mailed in boxes. This saves the City \$ 72 annually in mailing costs.
Avery B. Cawthorne	General Services	\$ 10	Ms. Cawthorne is an Intermediate Stenographer in the Administrative Division. She suggested that the Xerox Instructions; Form BD-195 include space for the job order. Although savings is difficult to estimate, a monetary award was felt to be warranted.
Kenneth R. Wood	Fire	\$ 10	Mr. Wood is a Firefighter. He suggested that the pockets on turn out coats be made larger so that necessary equipment may be carried therein. This is expected to save on coat damage and equipment loss.
Margaret A. Thomas	Risk Management	\$ 10	Ms. Thomas is a Senior Clerk in the Loss Prevention Division. She suggested that two different types of welcome letters to new employees be typed at the same time using a high grade of carbon paper. This saves approximately \$ 105 yearly.
