

RESOLUTION NO. 219726

Adopted on NOV 23 1977

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
David A. Pruitt	Fire	\$ 60	Mr. Pruitt is an Equipment Mechanic in the Fire Department. He constructed a drive shaft from over the counter materials. This saved the City \$609 in the purchase price from a vendor, and placed a valuable piece of equipment back in service.
Calvin Chong	Engineering & Development	\$ 25	Mr. Chong is an Assistant Civil Engineer. He suggested that the phrase "DO NOT DETACH THIS PAGE FROM THE CONTRACT DOCUMENTS" be added to bid packages. This will prevent the detachment of bid package pages, thus invalidating bids. Savings are difficult to calculate.
Joe Coyle	Police	\$ 20	Mr. Coyle is a Police Officer. He suggested that adhesive numbers be used for the identification of Police vehicles from the air. This alleviates several problems experienced with the use of water base paint, and saves the City \$200 annually.
Alger L. Thompson	General Services	\$ 20	Mr. Thompson was an Equipment Mechanic in the Equipment Division at the time of his suggestion. He suggested a safer and more economical method of extending the gear shift levers on road rollers. His method saves the City \$ 194 yearly.
