

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a lease agreement with RICHARD J. LORAH, ET UX, as lessor, whereby City leases portions of Lots 11 and 12, Block 227, Pacific Beach (south side of Hornblend Street), for the purpose of setting up a mobile home and patio-type garage as temporary Fire Station 21 at a monthly rental of \$720, plus utilities, beginning January 1, 1978 and terminating upon 30 days' written notice to lessor, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 761974.
