

That the appropriation and expenditure of \$6,192 from Capital Outlay Fund 245 (CIP 37-001.1(8)) of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for the purchase of materials and related costs for landscaping and irrigation of the western periphery of the ROSE CANYON OPERATIONS STATION in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above-referenced project pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
