

RESOLUTION NO. 219758 NOV 23 1977 (R. 78-545)

WHEREAS, Section 102.0809 of the San Diego Municipal Code requires that the MAP OF POPULATION-BASED PARK SERVICE DISTRICTS OF THE CITY OF SAN DIEGO be presented at least annually to the City Council for review and ratification; and

WHEREAS, the 1976 map adopted by Resolution No. 215844 is now due for review and ratification; and

WHEREAS, the map presently being submitted for adoption is a refinement of the said 1976 map providing for some minor adjustments in boundaries among some previously established districts as follows:

a. The addition of Park Service Districts #201 and #202 adjacent to the Del Mar border to accommodate subdivision activity.

b. The addition of seven new park service districts and revisions to existing park service district boundaries in the North City West area to conform to the adopted community plan.

c. Revision to the southerly boundary of PSD #504 to include the Bird Rock Elementary School into PSD #504. This proposed action will facilitate the turfing of the Bird Rock Elementary School playground to provide some park type amenities to the residents of PSD #504.

d. Minor realignment of the boundaries between #662-#662 and #664-#665 to reflect I-805 alignment.

e. Realignment of the east boundary of PSD #732 to accommodate subdivision activity.
