BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the sole bid received September 20, 1977, for the IMPROVEMENT OF 61ST STREET BETWEEN SKYLINE DRIVE AND IMPERIAL AVENUE, BENSON AVENUE FROM 61ST STREET TO 450 FEET EASTERLY; SKYLINE DRIVE AT 61ST STREET; CONSTRUCTION OF SEWER MAIN IN BENSON AVENUE BETWEEN 61ST STREET AND 65TH STREET, is hereby rejected.

2. That the Purchasing Agent is hereby authorized to readvertise for bids for the IMPROVEMENT OF 61ST STREET BETWEEN SKYLINE DRIVE AND IMPERIAL AVENUE, BENSON AVENUE FROM 61ST STREET TO 450 FEET EASTERLY AND SKYLINE DRIVE AT 61ST STREET, pursuant to revised plans and specifications on file in the office of the City Clerk as Document No. 761875 previously approved by the City Council by Resolution No. 219202 adopted August 31, 1977.
