RESOLUTION NO. 219763

WHEREAS, the City Council, by Resolution No. 218970, adopted August 3, 1977, accepted the bid of KENNETH H. FREELAND, dba COAST GLASS COMPANY, to construct security glass doors in the City Administration Building; and

WHEREAS, COAST GLASS COMPANY by refusing to sign a written contract and refusal to supply satisfactory and adequate materials required by the terms of the specifications and contract, has manifested its intent to breach the contract requirements; and

WHEREAS, the specifications provide that in the event of a failure of the contractor to perform, the City may let the contract to the next lowest bidder; and

WHEREAS, the five floors of the City Administration Building are in need of the glass doors to effect needed security; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Without giving up any legal or equitable rights accruing to The City of San Diego, and in recognition of the breach of the contract by KENNETH H. FREELAND, dba COAST GLASS COMPANY, this Council does hereby find that KENNETH H. FREELAND, dba ~~COAST GLASS~~ COMPANY, is in default of the contract adopted by Resolution No. 218970 on August 3, 1977.

2. That the City Attorney is directed to take all remedies both equitable and legal that may be available to the City as a consequence of the breach of said contract by KENNETH H. FREELAND, dba COAST GLASS COMPANY.


