

APPROVING MAP OF KEARNY MESA-DUNN BUSINESS PARK UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "KEARNY MESA-DUNN BUSINESS PARK UNIT NO. 2 being a subdivision of a portion of Lot 1 of Nichols Ridge, according to Map thereof No. 4883, together with a portion of Lot 2 of New Riverside, according to Map thereof No. 679, together with a portion of Othello Street as dedicated to public use, all in the City of San Diego, County of San Diego, State of California, as shown in the office of County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Ostrow Street and Wilkerson Court for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication portions of Lots 12, 13 and 14 marked "~~Reserved~~ for Future Street" as shown on this map, under the provisions of Government Code Section 66440.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any



and all abutters' rights of access in and to Dellwood Street, adjacent and contiguous to Lots 12, 13 and 14, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected Lots 12, 13 and 14 marked "Reserved for Future Street," shown on this map within this subdivision, all as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
