BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$2,000 is hereby authorized to match \$2,000 provided by the La Jolla Town Council for the beautification of La Jolla.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer \$2,000 from the Unallocated Reserve of General Fund (100) to program 52.06.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to enter into an agreement with the La Jolla Town Council in accordance with Council Policy 100-3.

BE IT FURTHER RESOLVED, that provisions of Council Policy 100-3 be waived to the extent it would prohibit purchase of equipment with these funds.
