

RESOLUTION NO. 219809 NOV 30 1977 8-937


A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 758495, AS AMENDED, BY ADDING PROJECT NO. 46-009, ENTITLED "SOUTH BAY WASTEWATER SYSTEM AND RELATED FACILITIES," TO THE FISCAL YEAR 1977-78 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING AND DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER FUNDS IN THE SUM OF \$8,500,000 FOR THE ABOVE PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 2, subsection 23 of 1977-78 Annual Appropriation Ordinance No. 12135, the Capital Improvements Program as contained in Document No. 758495, as amended by Documents No. 760516 and No. 761079, is hereby further amended by adding C.I.P. Project No. 46-009, South Bay Wastewater System And Related Facilities to the fiscal year 1977-78 C.I.P. Program.

2. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the Water Revenue Fund 506 the sum of \$8,500,000 from the Unallocated Reserve (69.97) to C.I.P. Engineering (69.42) to provide funds for the above C.I.P. Project No. 46-009.
