WHEREAS, at the Regular Meeting of May 10, 1977, the Housing Authority of The City of San Diego adopted Resolution No. 185 which (1) determined that there is a need in the City of San Diego for low-rent housing to meet needs not being adequately met by private enterprise and (2) authorized the Chairman to submit an application to the Department of Housing and Urban Development (HUD) for fund reservation for approximately 294 dwelling units of low-rent public housing; and

WHEREAS, on May 30, 1977, HUD advertised by Notification of Housing Assistance Availability (NOHAA) for 300 units of low-rent public housing in San Diego County; and

WHEREAS, in response to HUD's NOHAA letter and conversations with HUD officials, two applications were submitted to HUD on July 5, 1977, which requested 245 units of Family Existing (without Substantial Rehabilitation) housing and 171 units of Elderly New Construction housing; and

WHEREAS, pursuant to that submittal, HUD requests that in conjunction with those applications The City of San Diego must submit to HUD a preliminary loan application for undertaking and carrying out preliminary planning of low-rent housing projects that will assist in meeting the low-income housing needs of the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to submit a preliminary loan application to the United States


