
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant Deed of LAWRENCE BAKER and RUTH M. BAKER, husband and wife as joint tenants, executed in favor of the City of San Diego, bearing date of September 20, 1977, conveying to said City Lot 517 of Montgomery Palisades Unit No. 3 and the underlying fee to a portion of Palm Avenue dedicated for public use, for the proposed Otay Mesa Fire Station site, as more particularly described in said deed, be, and the same is hereby approved.

That the expenditure of \$60,500 from the Community Development Block Grant Funds to cover acquisition and relocation costs of the above described property is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
