1. That the bid of \$84,894.10 by CARVER CORPORATION, a corporation, for THE CONSTRUCTION OF CENTER STREET AND EAST BEYER BOULEVARD DRAIN, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 761261.
2. That the expenditure of \$16,000.00 is hereby authorized out of the Capital Outlay Fund 245 and that the expenditure of \$31,300.00 is hereby authorized out of Gas Tax Funds, CIP 11-153; and that the expenditure of \$22,500.00 is hereby authorized out of the Capital Outlay Fund 245 Reserve and that the expenditure of \$30,500.00 is hereby authorized out of the Gas Tax Fund 220 Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
