APPROVING MAP OF BAY TERRACE VIEWS SUBDIVISION AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF
COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM:

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by RONALD D. HOGAN, a Registered Civil Engineer, entitled "BAY
TERRACE VIEWS Being a subdivision of Lot 813 of Bay Terraces
Unit Nol 9, in the City of San Diego, County of San Diego,
State of California, according to Map thereof No. 7024, filed
in the office of County Recorder of San Diego County, August 17,
1971, together with portions of Doriana Street, Jamie Avenue
and Woodman Street as dedicated to public use.", is made in the
manner and form prescribed by law and conforms to the surrounding
surveys; that said map and the subdivision of land shown thereon
is hereby approved and accepted; and said Council hereby accepts
on behalf of the public, the following: Fuji Street and Leighton
Court for public purposes; and said streets are hereby declared
to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
any and all abutters' rights of access in and to Jamie Avenue,
adjacent and contiguous to Lots 1 through 7 and Lots 28 through
30; in and to Doriana Street, adjacent and contiguous to
Lots 7 through 20; and in and to Woodman Street, adjacent and
contiguous to Lots 21 through 28, all as shown on this map
within this subdivision and subject to the conditions set forth
thereon.



BREN COMPANY, a California corporation, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of BAY TERRACE VIEWS.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
