AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF
COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by EMORY P. GILBIN, a Registered Civil Engineer, entitled "IMPERIAL '80' UNIT NO. 5 Being a subdivision of Lot 69 of Imperial '80' Unit No. 1, according to Map thereof No. 8508 filed in the office of the County Recorder of San Diego County February 28, 1977 and of Lot 1 of Trinity Knoll, according to Map thereof No. 4266 filed in the office of the County Recorder of San Diego County, July 17, 1959, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Angelus Avenue, Leppert Court and Leppert Street for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby ~~accepts~~ on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Angelus Avenue, adjacent and contiguous to Lots 245, 246, and 252; and in and to Leppert Street, adjacent and contiguous to Lots 240, 241, and 242, all as shown on this map within this subdivision and subject to the conditions set forth thereon.



The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
