

FISH, husband and wife, and GARY FURSTENFELD, a married man as his sole and separate property, executed in favor of The City of San Diego, bearing date of October 31, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that portion of land designated as "Charmolee" and shown on Cave and McHatton Subdivision, in the City of San Diego, County of San Diego, State of California, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 59TH STREET.
