

RESOLUTION No. 219869

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of CHILCOTE, INC., a California corporation, executed in favor of The City of San Diego, bearing date of September 27, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that portion of Quarter Section Lot 79, Rancho de la Nacion, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named VARNEY DRIVE.

That the acceptance by the City Manager of that street easement deed of PENASQUITOS, INC., an Illinois corporation, executed in favor of The City of San Diego, bearing date of October 21, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that portion of Quarter Section Lot 78, Rancho de la Nacion, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named VARNEY DRIVE.
