
Adopted on DEC 14 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant Deed of JAMES R. HENLEY and MARTHA E. HENLEY, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of September 21, 1977, conveying to said City a permanent easement and right of way for a storm drain or drains; including all appurtenances thereto, together with the right of ingress and egress, over, under, upon, along and across all that portion of Lot A-187 of Addition No. 2 to San Ysidro, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named BLACKSHAW LANE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
