BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$10,700 from Federal Revenue Sharing Fund (2388) is hereby authorized for supplementing Resolution No. 217216 for the IMPROVEMENT OF ESCUELA STREET FROM IMPERIAL AVENUE TO NOGAL STREET, pursuant to the provisions of the Improvement Act of 1911.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces all the work of constructing 204 feet of chain link fencing and rebuilding a portion of a retaining wall along ESCUELA STREET FROM IMPERIAL AVENUE TO NOGAL STREET in the City of San Diego, California, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract.
