That the City Auditor and Comptroller be and he is hereby authorized to transfer \$3,000 within Capital Outlay Fund (Unallocated Reserve) and \$49,000 from Gasoline Tax (Unallocated Reserve) to Gas Tax Fund 220 (CIP 62-164) and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the installation of a traffic signal and safety lighting system at the intersection of CAMINO RUIZ and GOLD COAST DRIVE, in the City of San Diego.
