RESOLUTION NO. 219878

RESOLUTION DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION AND THE SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF SAN DIEGO, IN THE SAN DIEGO UNIFIED SCHOOL DISTRICT, AND IN THE SAN DIEGO COMMUNITY COLLEGE DISTRICT ON NOVEMBER 8, 1977.

WHEREAS, a general municipal election was held in the City of San Diego, the San Diego Unified School District, and in the San Diego Community College District on Tuesday, November 8, 1977, pursuant to the provisions of Ordinance No. 12175 (New Series) for the purpose of electing candidates; and

WHEREAS, this Council by Ordinance No. 12130 (New Series) adopted August 17, 1977, called a special municipal election to be held in the City on the same date for the purpose of proposing and submitting to the qualified voters of the City seven propositions to amend the Charter of The City of San Diego and one proposition relating to the implementation of a paramedic program in the City of San Diego as follows:

PROPOSITION A

PROPOSITION A. CITY OF SAN DIEGO CHARTER AMENDMENT. AMEND SECTION 113 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Transfers duty to publish the notice calling for proposals to do the official advertising of the City from the City Clerk to the Purchasing Agent.

PROPOSITION B

PROPOSITION B. CITY OF SAN DIEGO CHARTER AMENDMENT. AMEND SECTION 26 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Provides that any function of the County may be transferred to and performed by The City of San Diego if authorized by law and approved by the Board of Supervisors and City Council.

PROPOSITION C

PROPOSITION C. CITY OF SAN DIEGO PARAMEDIC PROGRAM PROPOSAL.

Do you approve implementation of a paramedic program in the City of San Diego, operated by the City of San Diego, which would when fully implemented (in 1983), cost approximately \$3,400,000 annually, and require a revenue increase equivalent to 10 cents per each \$100 assessed valuation on the Property Tax Rate?

PROPOSITION D

PROPOSITION D. CITY OF SAN DIEGO CHARTER AMENDMENT. AMEND SECTION 110 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Requires a person desiring to make a claim against the City to file the claim with an official designated to accept claim rather than specifically with the City Clerk.

PROPOSITION E

PROPOSITION E. CITY OF SAN DIEGO CHARTER AMENDMENT. AMEND SECTION 30 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Deletes provision requiring the Civil Service Commission or City Council to conduct a hearing in respect to removal of Unclassified Officers and Employees.

PROPOSITION F

PROPOSITION F. CITY OF SAN DIEGO CHARTER AMENDMENT. AMEND SECTION 70 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Removes the requirement that the Civil Service Commission provide a schedule of salaries for the information of the Council.

PROPOSITION G

PROPOSITION G. CITY OF SAN DIEGO CHARTER AMENDMENT. ADDS SECTION 34 AND AMENDS SECTION 117 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Establishes the position of Legislative Analyst whose primary duty is to make recommendations for reductions in municipal spending in order to reduce taxes.

PROPOSITION H

PROPOSITION H. CITY OF SAN DIEGO CHARTER AMENDMENT. AMEND SECTION 130 OF THE CHARTER OF THE CITY OF SAN DIEGO.

Relieves the Civil Service Commission of the duty of making recommendations to the Council on minimum and maximum salaries at the time of the consideration of the annual salary ordinance and replaces it with the duty to identify classification of employees meriting special salary consideration.

WHEREAS, a copy of the certificate of the Registrar of Voters of the County of San Diego canvassing the returns of the general municipal election and the special municipal election, including absentee votes cast, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

1. The total number of votes cast in the City, including absentee votes, was 141,664.

2. The total number of votes cast in the San Diego Unified School District, including absentee votes, was 131,812.

3. The total number of votes cast in the San Diego Community College District, including absentee votes, was 131,812.

4. The total number of votes, including absentee votes, received by each municipal candidate and each candidate for the Board of Education of the San Diego Unified School District and each candidate for the Governing Board of Trustees of the San Diego Community College District is as follows:

a. FOR COUNCILMAN DISTRICT NO. 1:

BILL MITCHELL, having received a majority of all votes cast in the general municipal election for the office of Councilman District No. 1, is hereby declared election to the office of Councilman District No. 1 for a four-year term.

b. FOR COUNCILMAN DISTRICT NO. 3:

BILL LOWERY, having received a majority of all votes cast in the general municipal election for the office of Councilman District No. 3, is hereby ~~declared~~ elected to the office of Councilman District No. 3 for a four-year term.


