BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the plan of study entitled "San Diego Area-Wide Reclamation Study," a copy of which is on file in the office of the City Clerk as Document No. 762179 be and it is hereby approved.


That the City's Comprehensive Planning Organization (CPO) representative be and he is hereby directed to approve the plan of study at the December 19, 1977 CPO Board of Directors meeting.

That the City Manager be and he is hereby authorized to submit an application jointly with the County of San Diego to the State Water Quality Control Board for a study grant in the amount of \$500,000 and to accept the grant offer should one be tendered.

That the expenditure of a sum not to exceed \$31,250 is hereby authorized out of Water Utilities Unallocated Reserve Fund 506 for the sole and exclusive purpose of providing funds for the City's share of the cost of the study.

That two members of the City Council be appointed to serve on the Study Policy Committee and that the appointments come from the membership of the Transportation and Land Use Committee.
