

RESOLUTION NO. 219911

WHEREAS, the Greater San Diego Sports Association proposes to establish a post-season college bowl game commencing in 1978 between the Western Athletic Conference Champion, as the host team, and a nationally ranked major university football team; and

WHEREAS, the proposed post-season college bowl game would take place at the San Diego Stadium; and

WHEREAS, this bowl game would promote and benefit The City of San Diego; and

WHEREAS, the City Council will support said college bowl game in the amount of \$100,000 if the Greater San Diego Sports Association obtains National Collegiate Athletic Association certification and guarantees to raise \$400,000 from ticket sales as well as additional financing from the private sector; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized and directed to establish within the Transient Occupancy Tax Fund a special 1978 Post-Season College Bowl account and to transfer within the Transient Occupancy Tax Fund the sum of \$65,000 from Fund 223 and \$35,000 from Fund 224 to said special account.





