1. McCUNE MOTORS for Section I - twenty-one (21) each compact 4-door sedans (Plymouth Volare) for a cost of \$4,263.76 each for a total cost of \$89,538.96; terms net 21 days plus sales tax, less trade-in allowance of \$2,510.00 total for seven (7) Ford sedans and Section II - five (5) each Intermediate 4-door sedans (Plymouth Fury) for a cost of \$5,537.79 each for a total cost of \$27,688.95; terms net 21 days plus sales tax, less a trade-in allowance of \$1,975.00 total for five (5) used vehicles.
2. CARL BURGER DODGE for Section III - two (2) each 3/4 ton pickup trucks for a cost of \$5,475.00 each for a total cost of \$10,950.00; terms net 30 days, plus sales tax less trade-in allowance of \$1,000.00 for one (1) 3/4 ton Chevrolet pickup.
