APPROVING MAP OF RAINBOW GREENS SUBDIVISION

DEC 21 1977

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, a Licensed Land Surveyor, entitled "RAINBOW GREENS Being a subdivision of a portion of the Northwest Quarter of Section 34, Township 18 South, Range 2 West, San Bernardino Meridian, including portions of the tract named "George" and of Lot 11 of Tibbett's Tract amended map of the south half of the Southwest Quarter of Section 27 and the north half of the Northwest Quarter of Section 34 in Township 18 South, Range 2 West, San Bernardino Meridian, as shown on Licensed Survey Map No. 24, filed in the office of the County Recorder of San Diego County, November 25, 1892, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portions of Hollister Street and Tocayo Avenue for public purposes; and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Tocayo Avenue, adjacent and contiguous to Lots 2, 3, 4, and 5, all as shown on this map within this subdivision.



BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities; together with the easement for general utility purposes over, under, upon, and across portions of Lots 1 through 10, all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements for sewer and drainage facilities, together with the easement for general utility purposes, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
