
Adopted on DEC 21 1977

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ROBERT E. DES LAURIERS, ARCHITECT, a California corporation, to provide professional engineering services for design of micellaneous engineering and development projects to assist the blind and partly sighted persons within the City's right of way under the Federal Community Development Block Grant Program, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 762213.

BE IT FURTHER RESOLVED, that the expenditure of \$40,000 is hereby authorized out of Federal Community Development Block Grant Fund 290/2930 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
