BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of \$150.00 from the Ocean Beach Recreation Council and directs that said contribution be deposited in Capital Outlay Fund 245 and thereafter be matched by an additional \$150.00 from The City of San Diego to be used exclusively for the purpose of purchasing a basketball backstop for the Ocean Beach Recreation Center.

2. That the expenditure of \$150.00 from the Capital Outlay Fund 245 is hereby authorized solely and exclusively for the purchase and installation of a basketball backstop for the Ocean Beach Recreation Center.

3. That this Council does hereby commend the Ocean Beach Recreation Council for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to the Ocean Beach Recreation Council.
