

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease agreement with SAM BARR, as Lessee, for the purposes of operating and maintaining a food market and restaurant and for such other related or incidental purposes as may first be approved in writing by the City and for no other purposes, at a monthly rental of \$1,650 for the first three years, subject to Consumer Price Index adjustments at three-year intervals, for a term of 20 years, under the terms and conditions set forth in that form of lease agreement on file in the office of the City Clerk as Document No. 762224.
