RESOLUTION NO. 219961

WHEREAS, the dumping and depositing of junk, waste materials and trash has occurred upon various vacant lots and upon improved and occupied premises in various areas within the City of San Diego; and

WHEREAS, numerous residents have complained about various public nuisances arising out of such dumping; and

WHEREAS, it now appears that there is a serious need to provide prompt and effective legal remedies to eliminate various community problems caused by the dumping and depositing of junk, waste materials and trash in various areas of the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager along with City staff from all appropriate City departments, and the City Attorney, form a task force for the purpose of studying the issue of dumping.

2. That said task force shall review the various aspects of the problem, shall review existing state and local laws and ordinances on the subject, and shall make recommendations as to any necessary changes in City policy, procedures and ordinances, which may be required to provide a prompt, effective and lawful method of prohibiting and abating dumping activities in the City.
