APPROVING MAP OF MONARCH VIEWS

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by RONALD D. HOGAN, a Registered Civil Engineer, entitled "MONARCH VIEWS Being a subdivision of that portion of Acre Lot 2 of Pacific Beach, in the City of San Diego, County of San Diego, State of California, according to Maps thereof No. 791 and 854, filed in the office of the County Recorder of San Diego County and together with a portion of Fanuel Street as closed and vacated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Kaimalino Lane and a portion of Archer Street, and said street and portion of a street are hereby declared to be a public street and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Kaimalino Lane, adjacent and contiguous to Lots 5 and 6, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said


