WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street to be vacated has been superseded by relocation; and

WHEREAS, an unnamed street located easterly of Governor Drive has been relocated by the approval on this date of the dedication of the street system within TOPEKA VALE UNIT NO. 1 by the acceptance of the final map of the subdivision; and

WHEREAS, those properties adjoining the unnamed street to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as TOPEKA VALE UNIT NO. 1;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the unnamed street located easterly of Governor Drive, as more particularly shown on Drawing No. 14128-B on file in the office of the City Clerk as Document No. 762280, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

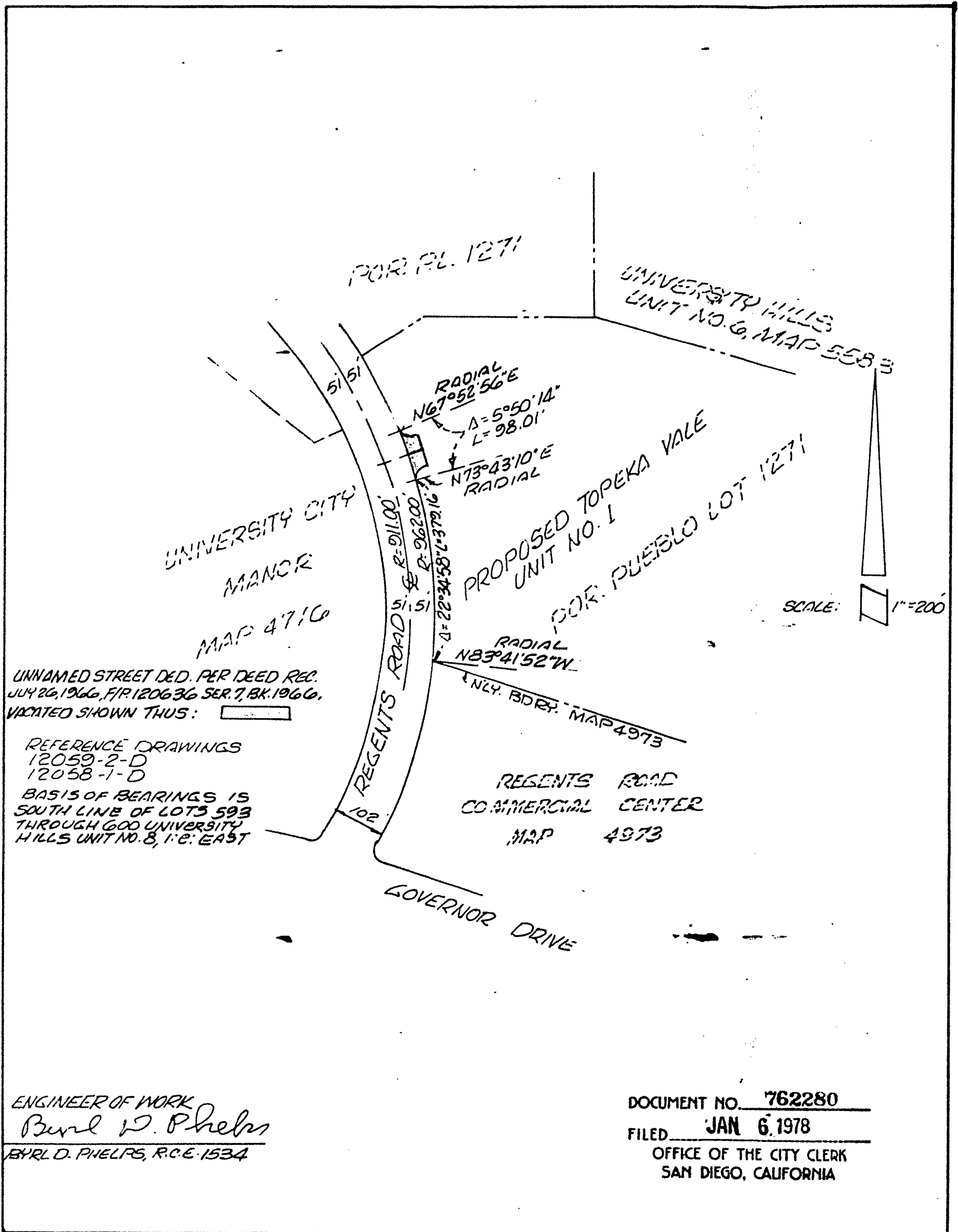

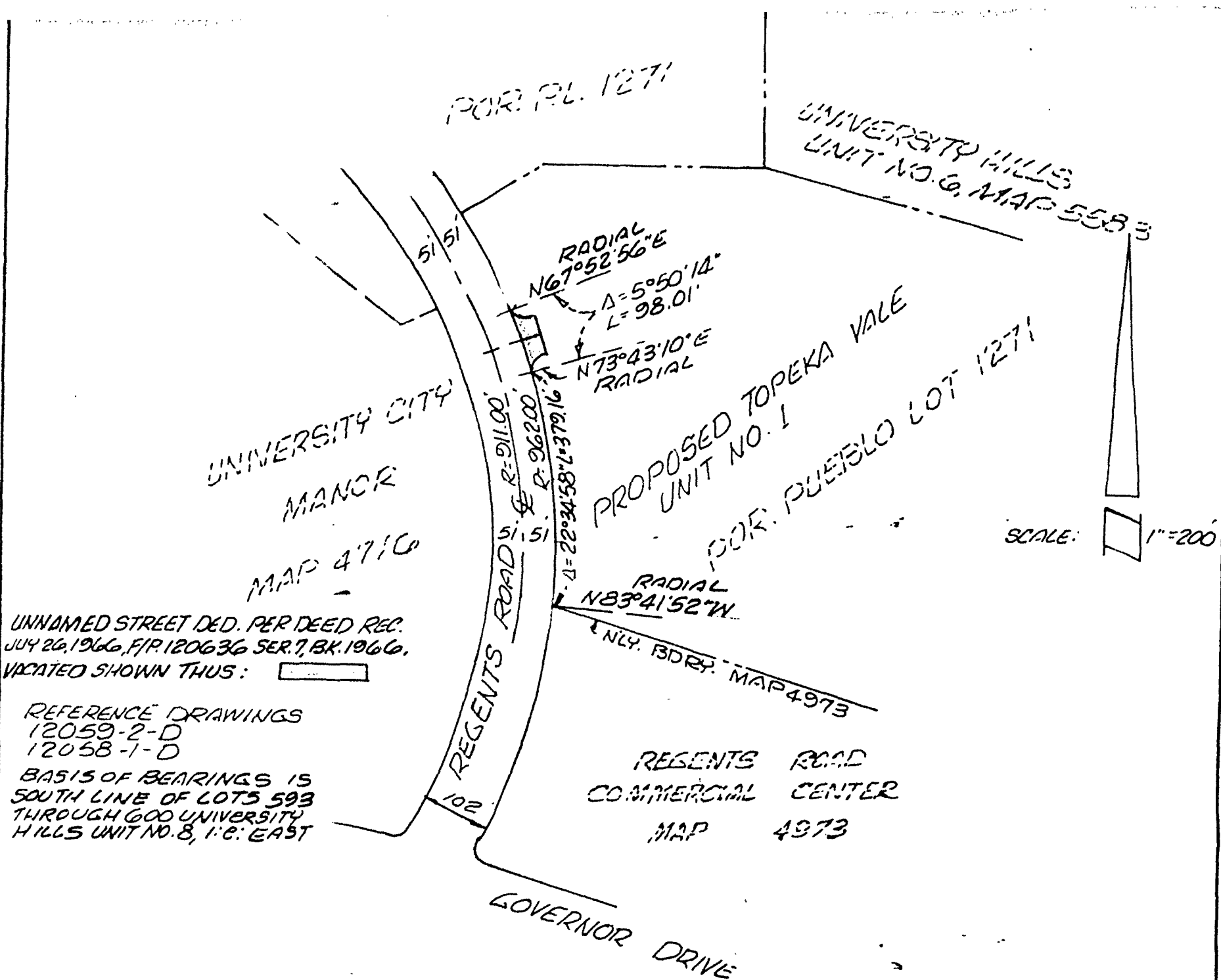
